AFSA HQ Update

TUESDAY, August 2, 2005:

This week the House is scheduled to consider H.R. 2863, the Department of Defense Appropriations Act for FY 2006. The \$409 billion bill contains \$363.7 billion in base funding and creates a \$45.3 billion "bridge fund" to cover expenses for military operations in Iraq and Afghanistan. H.R. 2863 would fully fund the proposed 3.1% military pay raise, as well as the cost of enhanced insurance and death gratuity benefits previously approved in the FY 2005 wartime supplemental spending bill. It includes an increase of \$20 million for Military Family Advocacy programs to fight domestic violence, and restores \$30 million of Impact Aid funding (previously cut). The bill also includes funding for several new aircraft purchases by the Air Force including 25 F/A-22 aircraft (\$3.2 billion), and 15 C-17's (\$3.5 billion). AFSA will continue to monitor progress on the bill and report the final details once the outcome is known.

What's Happening

Legislative Update

AFSA is currently supporting eleven bills that apply to Guard/Reserve members. Two of the bills are reviewed below:

S.639 & H.R. 783 - Sen Corzine, Jon S (D-NJ) Rep Saxton, Jim (R-NJ)

Title: A bill to amend title 10, United States Code, to reduce the age for receipt of military retired pay for nonregular service from 60 years of age to 55 years of age.

H.R.621 - Rep Beauprez, Bob (R-CO)

To amend the Internal Revenue Code of 1986 to allow penalty-free withdrawals from retirement plans during the period that a military reservist or national guardsman is called to active duty for an extended period, and for other purposes.
